ANNUAL REPORT IN BRIEF

In 2008 The Thomas Foundation distributed \$5.62 million to 13 projects and, despite the deteriorating financial situation, made forward commitments totalling a further \$7.25 million.

More than half of the grants were for conservation projects and programs of The Nature Conservancy's Australia Trust and Bush Heritage Australia. Assessment of applications was made against the Foundation's high standards.

Among non-conservation projects, support was given to the Australian Chamber Orchestra, the Catholic Education Office and Pathways to Manhood all of which are uniquely placed in their area of activity.

The Foundation's running costs continue to be tightly managed, and in 2008 totalled just \$46,850 - or less than 0.01 per cent of the total value of grants distributed. While anticipating these costs might increase slightly in the future, the Foundation aims for the highest levels of efficiencies in all that it does.

The global financial crisis has impacted heavily on the Foundation's corpus. Like other philanthropic organisations, the foundation has significant investments in equities that recorded losses over 2008, resulting in a \$2.077 million asset value rightdown at year's end.

Despite this, the Board remains confident it will meet all its commitments. As the year ended the Board brought a keen focus to the financial management of its assets to minimise further rightdowns as far as possible, and deferred all new funding commitments for now.

In April 2008 Keith Cottier AM retired after 10 years service on the board. Keith is an eminent Sydney architect and long-time conservationist. Thomas Foundation Chairman, David Thomas said that Keith had brought a great depth of knowledge and skills to the Thomas Foundation, and had been specifically involved in a number of projects involving music, architecture and nature conservation. "I am greatly indebted to the time and energy that Keith brought to the establishment of the Foundation and its achievements," David Thomas he added.

Rowland Hill was appointed to the Board in May 2008.
